### Veterinary Report on the Examination of a Dales Pony Colt for a Stallion Licence

Static Inspection:
The colt, in my opinion, meets the following criteria:
Has satisfactory conformation
Is free from clinical signs of contagious or infectious disease
Mouth: There is no evidence of malformation or misalignment of teeth and/or jaws, parrot mouth (defined as there being no overlap of incisor tables), cleft palate of any degree
Eyes: There is no evidence of abnormality of the lens, iris or retina
Throat: There are no signs of operation for wind defects
Limbs: There is no evidence of limb or foot abnormalities and/or disease likely to compromise the performance of
offspring
Genitalia: Both testicles are of normal texture, freely mobile and correctly orientated within the scrotum. There is n evidence of inguinal or scrotal hernia
Body: There is no evidence of umbilical hernia
Moving Inspection:
In Hand: Movement has been studied at walk and trot, turning and backing. The pony shows no signs of locking
patella, stringhalt, shivering and wobbler disease
Loose (younger pony), Lungeing or Ridden: Movement has been studied at canter. The pony shows no evidence of laryngeal hemiplegia
Any lameness has been investigated for cause

### **Guidance on Licensing a Dales Pony Stallion**

Please note that full information on the DPS Stallion Licensing Procedures can be found in the Members' Handbook or on the DPS website. The information below is for guidance only.

#### **Owner**

- 1. Ensure the colt is registered under your name with the Society, submit a transfer of ownership if not (fees apply).
- 2. All colts must be FIS clear. Ensure the colt has been FIS tested and this has been recorded by the Secretary, contact the Secretary if you need to have your colt tested (fees apply).
- 3. Contact the Secretary for the relevant stallion licensing forms and sample bag and to check your colt is eligible for licensing or provisional licensing (as detailed in the DPS Stallion Licensing Procedures).
- 4. Ensure your colt is well handled as a veterinary examination will take place as part of the procedure and a Veterinary Surgeon will not attempt to examine an unmanageable pony. Unbroken colts should be halter trained and accustomed to being handled.
- 5. Complete the Application to License a Dales Pony Stallion form in full. Ensure white markings are noted correctly and that all owners have signed and completed the owner's declaration.

  Note: Overseas applicants are required to send photographs of the pony with the application, to include views from both sides, front and rear of pony, plus additional photos if needed clearing showing any white markings.
- 6. The application will go to the DPS Council for approval, the Secretary will contact you with their decision.
- 7. If approved, a veterinary examination report form is then required (alternatively, and to speed up the process, this can be submitted at the same time as the application form). Your Veterinary Surgeon is required to examine the colt and complete the form in full, please ensure the Veterinary Surgeon signs and stamps the form. The Veterinary Surgeon is also required to take a hair sample from the colt at the time of examination. (Cost of examination is the responsibility of the colt owner).
- 8. The Secretary will advise if the veterinary examination is satisfactory and if the pony is being awarded a stallion licence. If approved, the Secretary will then ask for the stallion licence application fee and for the pony's passport to be sent to the office for updating. In some cases, the Council may ask to inspect the pony, as detailed in the Members' Handbook alongside appeal information.

#### **Veterinary Surgeon**

Please note that Dales Pony colts are only eligible for licensing as a stallion if they have the correct markings: 'A white star and/or snip on the head. White to the fetlocks of the hindlegs only.'

Mismarked ponies showing more white than this are registered as Section B and are not eligible for licensing.

- 1. Ensure the pony's description and microchip matches that within the passport; thoroughly check the heels of the front feet for white markings which may be hidden by feather.
- 2. Complete the Veterinary Report on the Examination of a Dales Pony Colt for a Stallion Licence form in full, checking off the list of criteria as appropriate.
- 3. Two year old colts are eligible to apply, it is likely that their moving inspection will have to be done loose rather than through lungeing.
- 4. Please sign, date and stamp the form.
- 5. Take a hair sample from the colt and place in the DNA sample bag provided; ensure there are a good amount of hair bulbs present on the sample and details on the bag have been filled in correctly.
