## Annual Stallion Service Log

*Please note that full information on the DPS Stallion and Registration Procedures can be found in the Members' Handbook or on the DPS website.  
The information below is for guidance only.*

Annual Stallion Service Log Sheets have replaced the Stallion Service Books, to save postage costs for both Stallion Owners and the Society. However, the traditional Stallion Service Books will still be issued to stallions on licensing if they are to be used on outside mares and completed **white service slips should still be given** to owners of outside mares when the mare is serviced. The mare owner(s) should enclose this slip as normal with their foal registration the following year. Foal registrations submitted for mares owned by the stallion owner(s) or registered keeper **do not** need to be accompanied by a white service slip.

All mares served should be recorded on the Annual Stallion Service Log which must be submitted by the owner(s) or registered keeper of **all stallions** who have served mares by 30th November each year. Failure to do so may lead to progeny requiring proof of parentage prior to registration.

Please complete a separate service log sheet for each stallion and use additional sheets if there is not enough room on one sheet.

Please ensure all documents are completed in full. Where there is more than one owner, **all owners must sign** the Stallion Service Log Sheet and Stallion Slips. Contact the Secretary to nominate a main point of contact if required.

The Stallion Service Log Sheet must include the **UELN** passport number of any mare that is not a Dales Pony, whose offspring will be eligible for the **Part Bred Register**.

Stallion Service Log Sheets are to be returned to the Honorary Secretary either via post to: Dales Pony Society, Hollybush Farm, Littlebeck, Whitby, YO22 5HY  
Or scanned and emailed to [dalesponysociety@gmail.com](mailto:dalesponysociety@gmail.com).  
Scans must be of suitable quality and not just a photograph of the sheet.

Stallion owners or registered keepers are contacted on an annual basis to establish the **status of their stallion for breeding purposes** and inclusion of up to date information in SPARKS sheets. Help us reduce administration by deleting as appropriate the sentence on serving of outside mares. If your stallion will be standing to outside mares, please detail via which method. Where AI is being used, mare owners must be provided with appropriate **semen release documents**, as the document will be required for foal registration purposes. Any registrations that are not accompanied by such documents will be required to be parentage tested using DNA from both parents.
